# • Inaccessible Dangerous Goods (IDG)

### • Limited Quantities Dangerous Goods (LDG)(4)

#### For Dangerous Goods transported by air (IATA) or by road (ADR)

#### • Dangerous Goods in Excepted Quantities (REQ)(4)

Package contains very small quantities of dangerous goods packed, marked and labelled in compliance with IATA or ADR regulations.

When transported by air (IATA), Dry Ice is a hazardous commodity that requires special handling, subject to simplified regulations. This means it can only be offered in locations where fully regulated Dangerous Goods services are offered.

When transported by road (ADR), Dry Ice is not considered as Dangerous Goods and therefore is not subject to these DG limitations in countries.
