



Remote Rural Surcharge for Ground Packages

Effective: January 6, 2025

Intra-Canada ground packages delivered to rural locations are assessed a remote rural surcharge. The following is a list of postal codes where these surcharges apply.

How to Calculate the Remote Rural Surcharge

1. Locate your package's destination postal code within the ranges listed.
2. If your package's destination postal code lies within the listed ranges, the remote rural surcharge applies.
3. The applicable remote rural surcharge amount is listed in the last column of the table.
4. An additional fee of \$40.50 will be applied to packages weighing over 100 lbs. (46 kg) that are shipped to these destinations.
