e-Transport Guide on transportation of goods falling under the scope of the Romanian legislation on e-Transport, carried out through FedEx Express Romania Transportation SRL

This Guide includes information on the steps you must follow if you have a shipment processed through FedEx Express Romania Transportation SRL (FedEx), which is subject to reporting in the e-Transport system.

July 2024

The Romanian e-Transport system monitors the road transport of goods within the national territory, which pose a high tax risk, and the international road transport of goods.

The obligation to report data in the Romanian e-Transport system concerning the transport of goods posing a high tax risk and of the goods falling under the scope of international road transport and, implicitly, to obtain the UIT code for such goods lies solely with the FedEx/TNT service users pursuant to Government Emergency Order (GEO) no. 41/2022.

The conditions for reporting and monitoring the transport of goods falling under the scope of e-Transport monitoring are laid down in the current legislation: GEO no. 41/2022 and the Joint Order of the President of the National Agency for Fiscal Administration and of the President of the Romanian Customs Authority. The FedEx/TNT service users are solely responsible for determining whether their shipments are subject to reporting in the e-Transport system. FedEx does not assume responsibility for the FedEx/TNT service users' failure to comply or for their inappropriate compliance with the obligations of reporting in the Romanian e-Transport system.

Note: FedEx Express Romania Transportation SRL is a postal services provider authorized by the National Communications Administration and Regulation Authority (Autoritatea Naţională pentru Administrare şi Reglementare în Comunicaţii – ANCOM).

All shipments sent via FedEx include at least one element of transport by road with road vehicles subject to monitoring in the Romanian e-Transport system, more specifically vehicles with a technically permissible maximum laden mass of at least 2.5 tons.

As for the national road transport of goods posing a high tax risk and for export consignments and intra-EU deliveries (including consignments carried out partially by air), we recommend you to initiate the process on the date when you are booking the shipment and when you have the shipment number (AWB). Note: the shipping date must be the same as the pickup date.

As for the intra-EU import consignments (including consignments carried out partially by air), we recommend you to track the FedEx and/or TNT shipment numbers (AWBs) in the tracking tools on our websites and to initiate the process for obtaining the UIT code on the day of collection, mentioning, as the date of the transport, the day of collection.

As for the non-EU import consignments (including consignments carried out partially by air), we recommend you to initiate the process for obtaining the UIT code when the FedEx and/or TNT shipment numbers (AWBs) appear scanned in Romania, in one of our hubs in Bucharest (OTP), Timisoara or Cluj-Napoca, mentioning, as the date of the transport, the day of receiving the prealert for customs clearance.

Entering data in the e-Transport system


The FedEx/TNT services user shall enter the FedEx data in the field '**Organizator transport**' (Consignment organizer):

Upon accessing the section 'Documente transport' (Consignment documents), in the field 'Tip document' (Document type), the FedEx/TNT services user shall include the consignment AWB* on the first line, selecting the option 'Altele' (Other).

In the field '**număr vehicul (cap tractor)**' [number of vehicle (tractor unit)], the FedEx/TNT services user must enter the relevant vehicle number identified in the list above.

FedEx will update the identification information of the road transport vehicle, during the period of validity of the UIT code, whenever this information changes, before any new movement of goods.
