## Issue of Customs Documents

## Disbursement Fee - Free Circulation

FedEx pays the Duty and Tax charges to the customs authorities on behalf of the customer. This incurs a Disbursement Fee, dependent on the Duty and Tax amount.

## Returned Goods

	RATE
FedEx can organize the return of your goods that either have temporarily been exported to another country for reasons such as repair, processing, testing, evaluation, trade shows, or goods that are being returned to the country of export in an unaltered state. This allows the importer to claim relief on Duty/ Tax with the necessary proof of export document. FedEx will charge a fee for the service.	€ 42 € per shipment

## Warehousing of the Goods With a Value of More Than € 150

The warehousing fee is invoiced to shipments, which cannot be released from our premises due to customer not meeting the customs clearance contract conditions (e.g. unclear or missing documents and/or information) or due to customer's request.

<b>Legal Entity</b> - Initial 7 calendar days free of charge, then according to the invoiced weight of the shipment:	up to 30 kg: € 5/day up to 125 kg: € 15/day over 125 kg: € 50/day
<b>Private Person</b> - Initial 7 calendar days free of charge, then:	€ 5/shipment/day
