FedEx® Delivery Signature Options	The following delivery signature options ⁽⁸⁾ may be chosen at the time of booking your shipment: 1. No Signature Required: FedEx will attempt to obtain a signature at the delivery address. If no one is available to sign, FedEx will deliver the package in a safe place without obtaining signature. 2. Indirect Signature Required: FedEx will obtain a signature from someone at the delivery address, from a neighbour or from a building manager. If no one is available to sign, FedEx will attempt to redeliver the package. 3. Direct Signature Required: FedEx will obtain a signature from someone at the delivery address only. If no one is available to sign, FedEx will attempt to redeliver the package. 4. Adult Signature Required: FedEx will obtain a signature from any person of legal age at the delivery address, subject to sighting of a valid ID. If no one eligible to sign is available, FedEx will attempt to redeliver the package. Additional Handling Surcharge	Package Services A surcharge applies to a shipment containing any package that: Dimension measures greater than 121 centimetres along its longest side; measures greater than 76 centimetres in length and girth (length + 2 x width + 2 x height). Packaging is not fully encased in an outer shipping container or packaging; is encased in an outer shipping container or packaging not made of corrugated fibreboard (cardboard) materials, including but not limited to metal, wood, canvas, leather, hard plastic, soft plastic, or expanded polystyrene foam (e.g. Styrofoam); is encased in an outer shipping container or packaging covered in shrink wrap or stretch wrap; is round or cylindrical, including (without limitation) mailing tubes, cans, buckets, barrels, tires, drums, or pails; is bound with metal, plastic, or cloth banding, or has wheels (e.g. a bicycle), casters, handles, or straps, including packages where the outer surface area is loosely wrapped, or where the contents protrude outside the surface area; could become entangled in, or cause damage to other packages or the FedEx sortation system. Weight has an actual weight greater than 31kg. FedEx Express reserves the right to assess Additional Handling charges for packages that require special handling or that require FedEx to apply additional packaging during transit. If a non-standard shipment is eligible for two or all three Additional Handling Surcharges (Dimension, Weight, or Packaging), only the one with highest charge will apply. Package shape and dimensions may change during transit, which can affect the package's surcharge eligibility. If the package shape and dimensions change during transit, FedEx may make appropriate adjustments to the shipment charges at any time. Additional Handling Surcharge – Non-stackable ⁽⁹⁾	A surcharge applies to any FedEx International Priority Freight, FedEx International Economy Freight, FedEx Regional Economy Freight, FedEx Priority Express Freight and FedEx Priority Freight shipment containing at least one piece, skid or pallet that is non-stackable. Non-stackable means that a piece, skid or pallet cannot be stacked vertically in a safe and secure manner. Examples include, but are not limited to, non-stackable freight handling units that: 1) do not have a flat and stable top or base, 2) may be damaged if another piece is loaded on them, or 3) have flat and stable loading surfaces but are too narrow to safely and securely support other freight handling units (e.g. 1-2 barrels or drums). Address Correction	If a recipient's address on an Air Bill, Air Waybill, Waybill or shipping label is incomplete or incorrect, we may attempt to find the correct address and complete delivery and we will assess a surcharge. If we are unable to complete delivery, we are not liable for failing to meet our delivery commitment. For FedEx International Broker Select, the address correction surcharge will apply if the broker's address is incomplete or incorrect on the Air Waybill, Waybill or other shipping documentation. If we cannot determine the correct address or cannot reach the broker, we may attempt to contact the sender for address clarification or instructions to return the shipment.
