² Air cargo space must be reserved in advance with our Customer Service team for the following shipments: (a) For the shipments originating from Asia countries/ territories (Australia, Cambodia, Mainland China, Guam, Hong Kong SAR China, Indonesia, Japan, Macau SAR China, Malaysia, New Zealand, Philippines, Singapore, South Korea, Taiwan China, Thailand, and Vietnam.), IP multiple-piece global third-party shipments with an actual weight of more than 500kg, or IPF global third-party shipments with an actual weight of more than 100kg or any individual package that measures greater than 274 centimeters along its longest side or measures greater than 203 centimeters along its second-longest side or measures greater than 178 centimeters along its third-longest side; or measures greater than 330 centimeters in its longest side and girth (Length + 2xWidth + 2xHeight). (b) For the shipments originating from other countries/ territories, IP multiple-piece global third-party shipments with an actual weight of more than 300kg, or IPF global third-party shipments (regardless of weight).

Remarks:

- Global third-party rates are for customers who have registered for the FedEx global third-party service only. For other customers, an export rate based on the origin country/ territory will apply. To find out if you are eligible for FedEx global third-party service please contact FedEx Customer Service team.
- IPF service may not be available for some origins and destinations. For service availability information please contact FedEx Customer Service team.
- A fuel surcharge and other special fees will apply.
- A 68kg minimum rate charge per package shall apply to IPF shipments of less than 68kg. Your contractual discount will not be reflected for IPF shipment less than 68kg. Please contact FedEx Customer Service team for details.
