Fuel Surcharge

Demand Surcharge

Address Correction: CNY 83.00 per shipment

If a recipient's address on an Air Bill, Air Waybill or shipping label is incomplete or incorrect, we may attempt to find the correct address and complete delivery and we will assess a surcharge. If we are unable to complete delivery, we are not liable for failing to meet our delivery commitment. For FedEx International Broker Select, the address correction surcharge will apply if the broker's address is incomplete or incorrect on the Air Waybill or other shipping documentation. If we cannot determine the correct address or cannot reach the broker, we may attempt to contact the sender for address clarification or instructions to return the shipment. If we are unable to complete delivery under these circumstances, we will not be liable for failing to meet our delivery commitment.

International Shipment Data Entry Surcharge: FedEx charges a surcharge for use of handwritten Air Waybill of international shipment (including shipment to Hong Kong, Macau and Taiwan). The surcharge is CNY 20.00 per shipment.

U.S. Inbound Processing Fee: CNY 10.80 per shipment. A charge will be assessed on all international shipments imported into the U.S. in connection with the processing of those shipments for customs clearance.

Residential Delivery Surcharge: CNY 24.00 per non-freight shipment (applicable to US & Canada destinations only). If the ODA Surcharge is applied to a shipment, the Residential Delivery Surcharge will not apply.

Declared Value Charge for Carriage: Liability of FedEx for loss, damage or delay of your shipment is limited to the greater of about USD20.00 per kilogram or USD100.00 per shipment. The exact limitation may be expressed in Special Drawing Rights or local currency and the exact amount will vary depending upon the country/ territory of origin and currency.

If you desire that FedEx assumes liability for a greater percentage of the actual cargo value, then you must declare the value for carriage on your air waybill and pay a “declared value surcharge”.
