### Determine FedEx International DirectDistribution Rates, including IPD, IDF and IED

2. Determine your total shipment weight (round up to the next-higher kilogram).
3. Multiply the per-kilogram rate shown in the rate table by the total shipment weight.

### Fuel Surcharge

The surcharge percentage is adjusted every Monday, based on the US Gulf Coast Jet Fuel Index, and this percentage is applied to the total transportation charge (go to <https://www.fedex.com/en-au/home.html> for the prevailing fuel surcharge rate and a sample calculation).

### Demand Surcharge

During times of elevated shipping volumes, heightened demand for capacity, increased operating costs, and other strains on our network, FedEx may assess a Demand Surcharge.

### Special Handling Fees

Address Correction:<sup>1</sup> AUD 17.00 per delivery address

If a recipient's address on an Air Bill, Air Waybill or shipping label is incomplete or incorrect, we may attempt to find the correct address and complete delivery and we will assess a surcharge. If we are unable to complete delivery, we are not liable for failing to meet our delivery commitment.

For FedEx International Broker Select, the address correction surcharge will apply if the broker's address is incomplete or incorrect on the Air Waybill or other shipping documentation. If we cannot determine the correct address or cannot reach the broker, we may attempt to contact the sender for address clarification or instructions to return the shipment. If we are unable to complete delivery under these circumstances, we will not be liable for failing to meet our delivery commitment.

Third Party Billing Surcharge: 2.5% of total shipment charges

Third Party Billing Surcharge will apply to shipments that are billed to a third party. The surcharge will be charged to the third-party payer.

The surcharge applies when the shipper account number and the third party billing account number are not part of the same company, as determined by FedEx.

Residential Delivery Surcharge: AUD 4.60 per IPD delivery address or AUD 146.40 per IDF delivery address (applicable to US & Canada destinations only).

A residential delivery charge applies to shipments addressed to a home or private residence, including locations where a business is operated from a home, or to any shipment in which the shipper has designated the delivery address as a residence.

Inaccessible Dangerous Goods: AUD 120.00 per shipment or AUD 1.60 per kg, whichever is greater. A minimum billable weight may apply. Please visit <https://www.fedex.com/en-au/shipping.html> for details.

Dry Ice Surcharge: AUD 6.70 per shipment. If a shipment contains both dry ice and dangerous goods (accessible or inaccessible), only dangerous goods surcharge applies, and dry-ice surcharge is not applied.

Priority Alert - Package: AUD 83.10 per shipment or AUD 3.30 per kg, whichever is greater, for IPD

FedEx Priority Alert (FPA) is a specialized, fee-based and contract-only service specifically designed for customers requiring a high degree of shipment visibility and delivery compliance. By combining special boarding, enhanced shipment status tracking and operational recovery procedures, FPA provides an enhanced and reliable solution for your shipment. Please note that all requests need to be reviewed prior to acceptance in order to confirm service compliance and availability.

Priority Alert Plus - Package: AUD 99.80 per shipment or AUD 5.00 per kg, whichever is greater, for IPD

Our FedEx Priority Alert Plus (FPA+) service includes all the features of FPA as well as pro-active intervention capabilities for temperature sensitive shipments. With FPA+, re-icing, gel pack replenishments & cold storage are included as standard in the service. Please note that all requests need to be reviewed prior to acceptance in order to confirm service compliance and availability.

On-demand Care - Package: AUD 136.50 per shipment or AUD 6.00 per kg, whichever is greater, for IPD

On Demand Care (ODC) is a fee-based service for non-food items providing intervention services such as Dry Ice replenishment and gel pack reconditioning/ exchange, to protect the integrity of temperature-controlled shipments delayed in-transit. This service is not available at all locations. This service is not guaranteed and is subject to the identification of the shipment and must be booked via Customer Service.

**Duty and Tax:** If duties and taxes are levied on a shipment and FedEx pays them on behalf of the party responsible for payment, then that party must reimburse FedEx for the duties and taxes themselves, plus a FedEx surcharge that is based upon the type of shipment and its destination. **Declared Value Charge for Carriage:** Liability of FedEx for loss, damage or delay of your shipment is limited to the greater of about USD20.00 per kilogram or USD100.00 per shipment. The exact limitation may be expressed in Special Drawing Rights or local currency and the exact amount will vary depending upon the country/ territory of origin and currency. If you desire that FedEx assumes liability for a greater percentage of the actual cargo value, then you must declare the value for carriage on your air waybill and pay a "declared value surcharge". The "declared value surcharge" for Export shipments paid by Australia customers is equal to AUD 2.40 per AUD 100.00 (or fraction thereof) by which the declared value for carriage exceeds the greater of: (i) AUD 100.00 or (ii) AUD 12.03 per pound. ## Weight Information

Total shipment weight is unlimited. The maximum weight per package may be adjusted. Please contact our Customer Service team or Sales team for details.

Rates are calculated on the total weight of all packages on one international air waybill. Any fraction of a kilogram is rounded up to the next higher weight break. Such rounding may cause a variance in dimensional weight (volumetric weight) calculations. Please note that the rates stated on FedEx's invoice shall be the final and official rates.

Additional charges may be assessed for shipments below a certain weight density. The dimensional weight (volumetric weight) (in kg) of an IPD/IDF/IED shipment is calculated as follows. Please contact our Customer Service team for details.

3. IDF Minimum Charge. A minimum of 137kg rate charge shall apply in case the total weight of an IDF shipment is less than 137kg. Please contact our Customer Service team for details.
4. Advanced Booking Requirement. Air cargo space must be reserved in advance with our Customer Service team for IDF shipments with an actual weight of more than 100kg or any individual package that measures greater than 274 centimeters along its longest side or measures greater than 203 centimeters along its second-longest side or measures greater than 178 centimeters along its third-longest side; or measures greater than 330 centimeters in its longest side and girth (Length + 2xWidth + 2xHeight).
