Fuel Surcharge

The surcharge percentage is adjusted every Monday, based on the US Gulf Coast Jet Fuel Index, and this percentage is applied to the total transportation charge (go to https://www.fedex.com/en-kr/home.html for the prevailing fuel surcharge rate and a sample calculation)

During times of elevated shipping volumes, heightened demand for capacity, increased operating costs, and other strains on our network, FedEx may assess a Demand Surcharge.

Third Party Billing Surcharge:

- is encased in an outer shipping container covered in shrink wrap or stretch wrap

Non-Stackable Surcharge

Dry Ice Surcharge:
