You can customise your FedEx services to your needs (or the needs of your recipients) with value added services from FedEx Express. The following are descriptions of the fees applicable to value added services.

Dangerous Goods Only available on Express Services. FedEx Express Dangerous Goods services allow the shipping of regulated dangerous substances and materials including door-to-door delivery and customs clearance. Applicable fee depends on the Dangerous Goods type: • Accessible Dangerous Goods (ADG) The content of package must be accessible during transit for security reasons. • Inaccessible Dangerous Goods (IDG) The content of package does not have to be accessed during transit and can be mixed with other freight. • Dry Ice (DI) Dry ice is a hazardous commodity that requires special handling, subject to simplified regulations. This means it can be offered in locations where fully regulated Dangerous Goods services are not offered. • Lithium Batteries Section II (ELB) Four commodities are covered: 1. Lithium Ion packed with equipment (UN 3481 - Packing Instruction 966). 2. Lithium lon contained in equipment (UN 3481 - Packing Instruction 967). 3. Lithium Metal contained in equipment (UN 3091 - Packing Instruction 970). In case a shipment contains Dry Ice or Lithium Battery Section II with another Dangerous Good, only the respective (Accessible or Inaccessible) Dangerous Goods surcharge applies. Note: For Dangerous Goods, Lithium Batteries Section II (ELB) applies to FedEx® International Connect Plus®. FedEx® Delivery Signature Options The following delivery signature options(®) may be chosen at the time of booking your shipment: 1. No Signature Required: FedEx will attempt to obtain a signature at the delivery address. If no one is available to sign, FedEx will deliver the package in a safe place without obtaining signature. 2. Indirect Signature Required: FedEx will obtain a signature from someone at the delivery address, from a neighbour or from a building manager. If no one is available to sign, FedEx will attempt to redeliver the package. 3. Direct Signature Required: FedEx will obtain a signature from someone at the delivery address only. If no one is available to sign, FedEx will attempt to redeliver the package. 4. Adult Signature Required: FedEx will obtain a signature from any person of legal age at the delivery address, subject to sighting of a valid ID. If no one eligible to sign is available, FedEx will attempt to redeliver the package. Package Services A surcharge applies per package or piece that:

Package shape and dimensions may change during transit, which can affect the package's dimensional weight and surcharge eligibility. If the package shape and dimensions change during transit, FedEx may make appropriate adjustments to the charges at any time. This surcharge applies per piece even if multiple pieces are bundled in a shipment. If a non-standard package is eligible for two or all three Additional Handling Surcharges (Dimension, Weight, or Packaging), only the one with highest charge will apply.	
FedEx Express reserves the right to assess Additional Handling charges for packages that require special handling or that require FedEx to apply additional packaging during transit.	
Freight Services A surcharge applies to any freight handling unit that measures greater than 157 centimetres along its longest side. This surcharge applies on a per-freight-handling-unit basis even if multiple pieces of freight are bundled in a shipment. We reserve the right to assess additional handling charges for freight and any freight handling unit that requires special handling during transit.	NOK 520/freight handling unit
Additional Handling Surcharge – Non-stackable ⁽⁹⁾	NOK 2,240/freight handling unit
A surcharge applies to any freight handling unit of a freight shipment that is non-stackable. Non-stackable means that the freight handling unit cannot be stacked vertically in a safe and secure manner. Examples include, but are not limited to, non-stackable freight handling units that: 1) do not have a flat and stable top or base, 2) may be damaged if another piece is loaded on them, or 3) have flat and stable loading surfaces but are too narrow to safely and securely support other freight handling units (e.g. 1-2 barrels or drums). A surcharge also applies to any freight handling unit identified by the shipper as non-stackable. This surcharge applies on a per-freight-handling-unit basis even if multiple pieces of freight are bundled in a shipment.

Address Correction If a recipient's address on an Air Bill, Air Waybill or shipping label is incomplete or incorrect, we may attempt to find the correct address and complete delivery and we will assess a surcharge. If we are unable to complete delivery, we are not liable for failing to meet our delivery commitment. For FedEx International Broker Select, the address correction surcharge will apply if the broker's address is incomplete or incorrect on the Air Waybill or other shipping documentation. If we cannot determine the correct address or cannot reach the broker, we may attempt to contact the sender for address clarification or instructions to return the shipment. If we are unable to complete delivery under these circumstances, we will not be liable for failing to meet our delivery commitment.	NOK 100/shipment
The sender may elect to pay an additional charge to specify a Declared Value for Carriage on the Air Waybill, above the standard limits of liability. FedEx Express does not provide cargo liability or all-risk insurance for shipments. The Declared Value for Carriage is limited to a maximum amount and may vary by location. The Declared Value for Carriage may not exceed: • FedEx® Envelope or Pak: US\$100 per shipment (or equivalent value in local currency); • Other services except freight transportation services: US\$50,000 per shipment (or equivalent value in local currency); • FedEx International Priority Freight, FedEx International Economy Freight and FedEx Regional Economy Freight: US\$100,000 per shipment to most destinations (or equivalent value in local currency); • For certain Unique Items: US\$1,000 per shipment (see our Terms and Conditions of Carriage for full details); • Actual value of the contents of the shipment; • Declared Value for Customs: The selling price or replacement cost of the shipment contents as required for Customs clearance purposes.	Declared Value rates are incremental and depend on the amount the customer declares. A fee of NOK 6.10 per US\$100 will be assessed for each additional US\$100 (or part thereof) of liability that FedEx Express accepts above the standard limits of liability.
Demand Surcharge (formerly known as Peak Surcharge) During times of elevated shipping volumes, heightened demand for capacity, increased operating costs, and other strains on our network, FedEx may assess a Demand Surcharge. The applicability, duration, and amount of the Demand Surcharge is determined for each region based on regular assessments of shipping volume and available capacity within our network and other considerations. Third Party Billing Third Party Billing Surcharge will apply to shipments that are billed to a third party. The surcharge will be charged to the third-party payer (10). The surcharge applies when the shipper account number and the third party billing account number are not part of the same company, as determined by FedEx.	2.5% of total shipment charges.
