No Signature Required: FedEx will attempt to obtain a signature at the delivery address. If no one is available to sign, FedEx will deliver the package in a safe place without obtaining signature.  2. Indirect Signature Required: FedEx will obtain a signature from someone at the delivery address or from somebody nearby, such as a neighbour or building manager. The recipient has the option to utilise any FedEx-approved means to authorise the shipment to be released without anyone present.  3. Direct Signature Required: FedEx will obtain a signature from someone at the delivery address only. If no one is available to sign, FedEx will attempt to redeliver the package.  4. Adult Signature Required: FedEx will obtain a signature from any person of legal age at the delivery address, subject to sighting of a valid ID.
