- 8. Skid/pallet **contains only one** Radioactive Material Excepted Package. [FX-03 (e)] Y N N/A

 - UN2910, Radioactive Material, Excepted Package – Limited Quantity of Material, 7, **RQ**
- 17. **UN number** preceded by prefix **"UN"** and corresponds to package markings. [10.8.3.9.1, Step 1] Y N

- 18. **Proper Shipping Name** and corresponds to package markings. 10.8.3.9.1, Step 2] Y N
- 19. **Class 7.** [10.8.3.9.1, Step 3] Y N
- 20. **24-hour emergency response telephone number**, including international prefix, if required by State or Operator variation. [2.8] Y N
- 21. **Name, date, and shipper's signature** (signature may be typewritten for U.S. domestic shipments, including U.S. territories) [10.8.3.13; 10.8.3.14; 10.8.3.15] Y N
