Whether you have pharmaceuticals that need to go to a patient overnight, a new glucose monitor to replace one that is broken, or a digital blood pressure monitor*, FedEx can help with your overnight or just-in-time critical needs and you do not need an account to ship.

When your healthcare shipment needs to arrive quickly, choose one of our next-day shipping services that delivers packages in the U.S.

To ship, you don't need an account.

FedEx First Overnight®:

Delivery the next-business-day morning by 8 a.m., 8:30 a.m., 9 a.m. or 9:30 a.m. to most areas. Additional extended delivery locations are guaranteed up to 2 p.m.



FedEx Priority Overnight®:

Delivery the next business day by 10:30 a.m. to most businesses in the contiguous U.S. and by noon to residences and 5:00 p.m. to some rural areas.



FedEx Standard Overnight®:

Next-business-day delivery by 5:00 p.m. to U.S. businesses and by 8 p.m. to residences.¹

Additional FedEx Express options for critical healthcare shipments:

FedEx SameDay®:

If you have extremely urgent shipments, use our same day services to deliver within 45 miles in select U.S. metro areas. You can choose from two options that deliver beyond 45 miles and are available 24/7, 365.²

FedEx 2Day®:

Have it there in 2 business days, as early as 10:30 to businesses or noon to homes.

FedEx Express Saver®:

Get shipments delivered in 3 business days, by afternoon to businesses or evening to homes.

Delivers packages to residential locations every day of the week, and is faster to more residential locations than UPS Ground.

A \$5 residential surcharge is added per package with FedEx Home Delivery.

Shipping medical devices with lithium batteries

Lithium batteries* are used in many medical devices and equipment, which means they may need special precautions and labeling for shipping. As long as the battery is in the device, it will stay grounded so don't attempt to remove the battery from the device. Make sure the device is turned off when you pack and ship it.

*Refer to the current FedEx Express lithium battery flow chart. For rechargeable lithium ion batteries of 100 Watts or less see UN 3481 Section II. If only lithium ion batteries are contained in equipment (i.e., in the device) with no spare batteries in the package see [Lithium Ion Batteries Contained in Equipment](#). If there are one or more spare batteries outside the device but in the same package see Lithium Ion Batteries Packed with Equipment.
