The new version of FedEx Ship Manager® software requires four – seven digit valid postal code to create shipments from or to Chile. If the provided postal code is invalid, you will receive an error message requesting that a valid postal code to be entered. Validation of postal code is available for pickup, sender/recipient addresses, broker addresses, and importer of record addresses.

The 'Limited quantity' option under special service is removed for ground hazmat shipments to, from, or within Hawaii or Alaska.

Rate quote for Intra Canada shipments will no longer include applicable taxes. A disclaimer is added in Transmit times, Courtesy rate quote screens, etc.,



COD and **ECOD** options are discontinued within **US**, **Origin**, or **Destination shipments** for FedEx Express® (FXE) and FedEx Ground® (FXG) services to enhance digital payment methods.
